

Carmel Lodge 421 F&AM PERMISSION TO PARK VEHICLE

Carmel Lodge 421 F&AM (hereinafter called "Lodge") hereby grants permission for \_\_\_\_\_ (hereinafter called "Permitee") to park their passenger car during the \_\_\_\_\_ school year in the parking lot of Lodge on school days Monday through Friday between the hours of 4:00 a.m. and 4:00 p.m. The following terms shall be followed:

1. Permitee will display the parking identification furnished by Lodge in clear view when parked at Lodge and will park only in the spot indicated below.
2. Lodge shall not be liable for any damage to any vehicle, for any cause or causes whatsoever, for the removal or loss of any integral parts, appliances or equipment, or spare tire fastened to such motor vehicle, or any part of any equipment locked in, contained in, or attached to such vehicle.
3. The Lodge assumes no duty and is not required to remove snow or any other impediment which would restrict the use of said parking space.
4. The Lodge will not be held responsible for any damage to any motor vehicle, or for any personal injury to any person, by reason of the use of said parking space.
5. The Lodge will not be held responsible for unpermitted parties parking at Lodge in Permitee's assigned space; however, Lodge will give its best effort to receive communication from Permitee's family of instances and call a towing company for repetitive infractions.
6. Permitee agrees to leave the premises in good condition and pickup any debris that has been removed from any vehicle.
7. The undersigned jointly and severally shall indemnify, defend by counsel acceptable to the Lodge, and its representatives, hold harmless from any loss, all claims, judgements, damages, penalties, fines, costs, liabilities or losses (including, without limitation, sums paid in settlement of claims, attorneys' fees consultant fees and expert fees) to any vehicle or personal injury connected with the use of said parking space. Said loss or damage includes any attorney fees involved.
8. This permission may be revoked at any time by either written or oral notice to any one of the Lodge.
9. Permitee will be attentive for and abide any communications from Lodge when there is a need to use Lodge parking for another purpose (e.g. on Election Day.) For this reason, Permitee's family will ensure Lodge has correct contact information throughout the school year.
